ELIGIBILITY & MATCH

VOCA ELIGIBILITY

Organizations whose principal mission is to serve crime victims

- Victim service organizations
- Public and nonprofit organizations
 - Component of the organization serves crime victims
- Use volunteers to provide crime victim services

Review the FY26 Grant Announcement for complete eligibility information.

FVPSA ELIGIBILITY

Organizations that assist victims of family violence, domestic violence, or dating violence and their dependents

- Local public agency
- Private nonprofit organization
- Partnership

An agency described above; and an agency that has a demonstrated history of serving populations in their communities.

Review the FY26 Grant Announcement for complete eligibility information.

STATE DV ELIGIBILITY

Organizations that provide a safe house or refuge and a crisis line

- Private, nonprofit corporation of the State of Idaho
- Public entity of the State of Idaho
- Note: No funds may be granted to batterer programs.

MATCH REQUIREMENTS



VOCA = 20% of total project cost FVPSA = 20% of total project cost Tribes are exempt from match requirements.



State DV funds = 25% 25% of your state award



Cash: non-Federal money contributions **In-Kind Contributions:** value of non-cash contributions



MATCH CALCULATION EXAMPLES


Federal Match

(Award) (80%) (Total Project Cost) \$150,000 ÷ .8 = \$187,500

(Total Project Cost) (20%) (Required Match) \$187,500 x .2 = \$37,500

State Match

(Award) (25%) (Required Match) \$20,000 x .25 = \$5,000



MATCH WAIVERS

VOCA Match Waivers are NOT automatic in FY26 but can be requested as needed.

Contact your Grant Manager for a Match Waiver Request Form. FVPSA and State DV Match cannot be waived.

APPLICATION, INSTRUCTIONS, & SUBMISSION

INSTRUCTIONS

- Complete application in AmpliFund
- Refer to the <u>Detailed Application Instructions</u>
- Complete the ICDVVA Budget Worksheet
 - Direct services = at least 65%
 - Administrative salaries = 5% cap
 - Executive Director salary = 93% cap*
 - Priority classifications for expense line items
 - PTO & Benefits
- New Appendix D: Indirect Cost Agreements

SCORING COMPONENTS

Council Scoring


2 Council members for each application

Staff Scoring

- 2 staff members for each application
- Agency Need Score
- Availability of Services Need Score
- Administrative Performance

Bonus Points

- Geographic Isolation
- Underserved Populations Need Score




BUDGET EVALUATION

Are expenses

- Eligible
- Allowable
- Reasonable

28 CFR § 94.103(a)

ICDVVA has sole discretion to determine which organizations will receive funds and in what amounts.



SCORE TIED TO FUNDING

- Application scores will determine the level of funding award
- Maximum application score without bonus points = 50
- Available bonus points = 10

Application Score	Funding Multiplier
50+	100%
45-49.99	98%
40-44.99	96%
35-39.99	94%
30-34.99	92%
0-29.99	0%



AWARD NOTIFICATION & SUBAWARD AGREEMENTS

NOTIFICATION & SUBAWARDS



- Sign & return final budgets
- Subaward agreements fully executed by September 30, 2025

Grant awards are not considered final until the subaward agreement has been fully executed by both parties.
