a. Regional Roundtable

On Wednesday, September 24, 2025 we will have our virtual Roundtable Event. Tamara Fife will be presenting training on programmatic and fiscal stability. We will have our Grant Administration webinar in the afternoon, and Darci Anderson, with Idaho Crime Victims Compensation, has been invited to speak about their new payment management system.

b. FY26 & FY27 Budgets

For the FY26 budget, there is a three percent holdback for ongoing General Funds. In FY27 the lobbyist working with the Idaho Children's Trust Fund will be working on getting another appropriation for State CAC funds.

c. Region 7 Council Seat

We are still waiting for a signature from the Governor's office to vacate the Region 7 Council Seat, and then we can discuss nominations.

d. Needs Assessment

The Victim Services Needs Assessment is based on the FVPSA monitoring report. The Council will be collaborating with the Idaho Coalition Against Sexual and Domestic Violence. The Council is contributing \$30k to the needs assessment in the form of a reimbursement to the Coalition.

e. Code Cleanup Project

Initially, we reviewed things that were deemed obsolete, or needed amended, but as of right now we are not moving forward with this.
